Process for courses with a Gen Ed Prerequisite

- Should all courses with a pre-req be listed on the SUNY Dashboard? They would all qualify.
- Pros/cons
- Advantages maximize transfer credits from one SUNY school to another
 - Courses would have to be accepted if they are labeled as general education courses
 - Leverages transfer of courses to other colleges
- If it is listed as a general education, has to be reviewed and assessed on same cycle as other courses
- As a note: In the near future, all courses may have to be assessed (3 or 5 year process)
- Per Middle States: Individual campuses are now responsible to "own" and assess their own General Education programs
- A question for the General Education Committee when courses are submitted, should we
 consider the context for why the course is being submitted for general education
 - Should this issue be raised at CAI and/or with the Academic Chairs to get input on the matter
 - May not be time to address this issue at this time
