- b. Information Literacy Discussion Committee may want to offer a suggestion on how Information Literacy will be carried out across campus
  - i. Possible Idea: Placed into a module and be required for student completion prior to graduation and tracked by the Registrar's Office
  - ii. Some programs are experiencing positive outcomes having the outcome in the program rather than a module.
  - iii. Programs could still have the outcome in their programs, but off-loading into a module can streamline reporting requirements and assist instructors with specific needs
  - iv. The module can be used to reinforce information to all students
  - v. 4 Modules would be required for graduation
  - vi. Concern The first SLO is discipline specific and the connection between discipline specific factors may not be connected and should still be connected to a course in a program that is measured and assessed
  - vii. Concern Moving to a module could become a barrier to graduation
  - viii. The outcome should still be assigned to a required course in a program
  - ix. Suggestion to keep this outcome in a required course in a program as we do not measure other outcomes such as Critical Thinking in this new proposed manner
  - x. Concern –How will the Registrar's Office follow up with all the students who do not complete the module for graduation purposes
  - xi. The proposed module should not take away from instructor control of the outcome as the information in the module details only the basics of Information Literacy
  - xii. Very few courses have come through adding this learning outcome and there was an impression that programs may not have to report this outcome anymore
  - xiii. Suggestion Moving the outcome out of courses structurally makes sense for reporting purposes
  - xiv. Concern Want to ensure that moving this to an independent module as a standalone is a concern
  - xv. Concern Tracking Core competencies such as critical thinking and other learning outcomes are already assessed and evident in curriculum mapping – Is easier better?
  - xvi. Concern Passing along a requirement to students may be problematic
  - xvii. Concern Why is this an issue? Why can we not assess this outcome in courses as we assess everything else?
  - xviii. Some programs are dealing with accreditation and other factors and are concerned about how to measure and assess this outcome in some programs
    - 1. After initial meetings positive discussions have occurred regarding which courses can house this requirement
  - xix. Concern Regarding the "why" and the precedent this might set
  - xx. Concern Assessment We can track completion rates, but what to do about that data, may be more difficult

- xxi. Moving Forward Gen Ed Committee members should take this information back to their respective constituencies, and seek further input and thoughts
